This targeted approach will ensure every participating student has the opportunity to access structured aquatic activities during primary school.

It is important that accurate information is recorded to ensure your child is placed in the appropriate group.

<b>Important</b>	The online enrolment portal will automatically close <b>3 school days</b> prior to our program start date. (Portal closes Tuesday 30 <sup>th</sup> November 21 at midnight). Please ensure you have registered your child by this time. <b>If your child/ren have not been registered online or a hard copy handed to the school or RLSSA ACT office, they will not be able to participate until this has been done.</b>
<b>Need to bring</b>	Swimmers (Wearing on arrival. Students <b>will not</b> have time to change in school prior to lessons), towel, goggles (optional) and warm clothes to change back into, in a bag with all items clearly labelled with their name. Please put these items in a plastic bag that is also clearly labelled. Students will be changing into warm clothes when they are back at school. Warm clothes to put on afterwards are essential.
